## **CEO Confidential Corner**

**Greetings to my fellow Stakeholders,**

With the first quarter behind us, and a month into the second, I am happy to report the Company has made significant progress. We have three company prospects interested in a specific Sertainty solution that will soon come out of testing and be ready for primetime. This first Sertainty-owned solution is needed by hundreds of companies who all have similar challenges with no obvious acceptable fix in sight. Continued mismanagement and theft of sensitive data is forcing the market to look for new, innovative solutions. All these events continue to build stakeholder value.

Another major accomplishment that is nearing completion is the conversion of our current engineering development platform, known as QT, to a new platform. This new platform is significantly more cost-effective to the Company and to our customers, and will give us greater cost-competitiveness in the commercial marketplace. We are positioning the Company very well for growth over the next several years.

Furthermore, I would like to introduce our two newest additions filling some major needs within our executive suite. First, join me in welcoming Robin Bienfait as our acting Chief Technology Officer (CTO). Robin first joined the Company late last year as an Advisory Board member. Robin is a global senior executive with 30 years of leadership experience in enterprise technology, mobility and security. Robin leveraged her C-level success driving transformation for AT&T, Blackberry, and Samsung. She sits on many boards, both private and public, and is the founder of EMNOVATE, an advisory firm that delivers enterprise class services to help businesses embrace innovation. Robin is a global influencer with 15 patents and is routinely tapped to present at global enterprise conferences, including CIO Forum, Gartner and Forrester. She has received extensive exposure in Forbes, Fortune and The Wall Street Journal, and was

recently named one of the top 100 CIO's in Science, Technology, Engineering and Math (STEM). Currently residing in Atlanta, Robin holds a master's degree in management of technology from Georgia Institute of Technology and a bachelor's degree in engineering from Central Missouri State University. We are very blessed to have Robin as part of our team.

I would also like to introduce Ian Browde, our Senior VP of Business Development. Ian has over 25 years high-tech and cyber-security experience in business development, marketing and leadership. During 8 years at Apple, he launched the company's presence in China through the University of Western China, Chengdu; trained Apple's education salesforce; led the Apple Managers' Seminar and created the Apple-San Jose State University MBA, an academia/corporate first. During 9 years at Nokia, he led the Message Protector team, a secure messaging first; oversaw implementation of RSA cyber-security soft tokens on Nokia phones and built co-marketing/sales alliances.

He attained success at SCO managing the strategic alliance with Compaq Americas. He continued his success at Trend Micro as VP of Business Development managing strategic alliances with Cisco, Citrix, Microsoft and Oracle, and later as VP of Business & Corporate Development at Lynx Software Technologies.

Ian has a B.A. in Political Science from Wits University, South Africa and his J.D. from Santa Clara University Law School, California.

These two additions are timely and welcomed in the Company as we turn this corner into the next phase of growth, which will build revenue and increase shareholder value.

### Global Telecom Update/ Project FileForge

The dialogue with a global telecommunications giant is continuing to evolve and expand. With the progress of Project FileForge toward commercialization this global telecom has decided to test "FileForge" as its first Proof For Customer (P4C) application. "FileForge" is an app-to-app file protection and governance solution that has wide-ranging use in automated data workflows. We are now in the process of finalizing the terms and conditions of the P4C licensing agreement. A successful trial will point the way to a commercial relationship with this global telecom company.

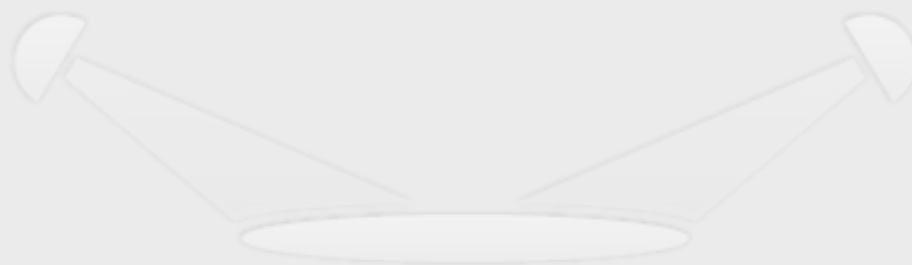
## Big Data Storage as a Service Provider
